



# Memorandum of Understanding (MoU)

(Recyclable Dry Waste & E-Waste Collection)

This Memorandum of Understanding (MoU) is made on 01<sup>st</sup> of June 2023 between Camp Education Society's Dr. Arvind B.Telang Institute of Hotel Management hereafter termed as 'Bulk Waste Generator (BWG)' and ProEarth Ecosystems Private Limited hereafter termed as 'Zero Waste Agency (ZWA)'

#### Background

The BWG and the ZWA have agreed to collaborate to conduct regular collection drives to make sure dry recyclable waste and e-waste can be channelled to responsible recyclers to promote waste management and environmental sustainability.

#### Scope of Work

The BWG and ZWA agree to work together to institute systems for source segregation of waste to segregate, collect, store and send for recycling at regular intervals mutually agreed between each other

#### Responsibilities

The BWG will support with following actions:

- 1. The BWG will support the initiative to appeal to its faculty and students to segregate their plastic, paper, glass, cardboard, e-waste and any other recyclable waste indicated by the ZWA. Facility management staff to be trained to keep the waste segregated in a designated stop for a pick up from ZWA.
- 2. BWG will institute waste segregation rules and install necessary infrastructure in the form of bins, trolleys and any other equipment that may be needed to ensure that waste remains segregated until pickup for recycling.
- 3. BWG will train all stakeholders in the waste management system to comply with the segregation rules.
- 4. The BWG will provide space in a suitable common area to collect & store the waste until pickup.
- 5. For E-Waste, BWG will provide an inventory list of materials to be recycled.

The ZWA will support with following actions:

- 1. The ZWA will provide electronic communication material such as Whatsapp posters to create awareness. BWG to share this with all the stakeholders.
- 2. The ZWA will provide training on chargeable basis to stakeholders to set the system within the institution.
- 3. The ZWA will clear the stored recyclable dry waste and e-waste from the premises at agreed intervals against a schedule.
- 4. The ZWA will provide certificates to indicate plastic and e-waste have been channelled to recyclers.

#### Additional Terms & Conditions

- 1. To set systems at the BWG for proper segregation, collection and storage, ZWA can conduct survey at the site and prepare a training & implementation plan. Accordingly, space can also be identified for the storage of waste. This will be charged according to the scope of work and a separate proposal will be provided for it.
- 2. The collection trips will take place on free of charge basis for both BWG and ZWA, i.e. both agencies will facilitate this initiative for no financial transactions between them.
- In case the quality of segregation and type of waste does not meet the standards for recycling, BWG and ZWA shall work out mutually agreeable way to ensure the quality of segregation is achieved.
- 4. Both parties understand the sprit in which this initiative is undertaken. The initiative is for a social & environmental cause to push segregation behaviour, increase recycling, reduce waste dumping and improve zero waste habits in the institute and as such will mutually work together to serve each other's benefits. In case it is experienced that one or both parties do not see any benefit in maintaining continuity in this activity for any reason, a mutual decision can be made to discontinue it.

#### **Duration**

This MoU will be valid for a period of 5 year from the date of signing. (01/06/2023 to 31/05/2028)

#### **Termination**

Either Party may terminate this MoU by providing written notice to the other Party. The termination shall be effective 30 days from the date of receipt of the notice.

#### Confidentiality

BWG and ZWA agree to maintain the confidentiality of any sensitive information disclosed to each other during the course of this MoU.

#### Governing Law

MIDC.

This MoU shall be governed by and construed in accordance with the laws of India under the jurisdiction of Pune.

# Memorandum of Understanding for E waste disposal

- **4.** The recycler will issue certificate of such disposal to the client for every delivery made by the client, in prescribed format.
- 5. All the legal issues will be deal in the legal jurisdiction of Kolhapur District.
- **6**. This MOU will be valid for 5 Years from date of inception i.e 15/12/2017.
